SLU PP 332 - laboratory stock and aliquot math

Laboratory stock-solution examples only. DMSO volumes and aliquots shown below are not syringe units, a route of administration, or human dosing instructions.

5 MG vial - 2 mL example

Dissolve in 2 mL DMSO

Concentration: 2.5 mg/mL

Each 1 uL aliquot = 2.5 mcg

5 MG vial - 1 mL example

Dissolve in 1 mL DMSO

Concentration: 5 mg/mL

Each 1 uL aliquot = 5 mcg

CALCULATION CHECK

Recalculate from the actual mass and final solvent volume. Use calibrated laboratory pipettes; never inject a DMSO stock solution.
